

**STATISTICAL REPORT FOR THE
FISCAL YEAR OCTOBER 1, 2014 - SEPTEMBER 30, 2015¹**

During the fiscal year, October 1, 2014 to September 30, 2015, the Court of Federal Claims disposed of 638 complaints and 676 vaccine petitions. Except for a number of these cases in which no given amounts were claimed, the total amount claimed was \$211,811,626,000.00. Of the cases disposed, the court rendered judgments for claimants in the sum of \$930,901,654.41 (annuity amounts are included in this figure) of which \$84,619,069.55 carried interest. A number of these judgments were based on settlements between parties. The Court of Federal Claims rendered no money judgments for the United States on counterclaims or offsets. Under its non-monetary jurisdiction (bid protest jurisdiction), the court's filings rose by 43% and the court's dispositions of these cases rose by 24% over the previous fiscal year (124 contract cases seeking injunctive or declaratory relief). Each January, pursuant to 28 U.S.C. § 791(c), the clerk transmits to Congress a statement of all the judgments rendered by the Court of Federal Claims which notes the names of the claimants, the amounts, the dates of entry, the nature of the claims, and the disposition for all judgments entered the previous fiscal year.

Case filings increased in fiscal year 2015 for both general jurisdiction cases and vaccine injury compensation cases. General jurisdiction cases increased by 13% while vaccine petitions increased by 26%. Many of the general jurisdiction case filings in fiscal year 2015 were of increased complexity and national significance. For example, 18% of general jurisdiction cases filed this past fiscal year contained multiple plaintiffs, and 12% involved intervening parties.

Total case terminations increased 4% from 1,265 in fiscal year 2014 to 1,314 in fiscal year 2015. Pending cases at the close of the fiscal year increased 4% from 2,528 on September 30, 2014 to 2,634 on September 30, 2015.
