## DECISION ON ATTORNEYS' FEES, ATTORNEYS' COSTS AND PERSONAL EXPENSES<sup>1</sup>

Petitioner, Kathy Edwards (Ms. Edwards), as the parent of her daughter, Joslyn Edwards (Joslyn), seeks an award of \$15,188.51 in attorneys' fees, attorneys' costs and personal expenses as defined by General Order No. 9 for an action that she pursued successfully under the National Vaccine Injury Compensation Program (Program).<sup>2</sup> See generally Petitioner's Application for Fees and Costs (Fee Petition), filed February 23, 2006. Respondent does not object apparently. See Fee Petition at 1. Because Ms. Edwards received Program compensation, the Act mandates the award of "reasonable attorneys' fees" and "other costs." § 300aa-15(e)(1). The special master has reviewed carefully the Fee Petition. Based upon his experience, he determines that an award of \$15,188.51 is appropriate.

As provided by Vaccine Rule 18(b), each party has 14 days within which to request redaction "of any information furnished by that party (1) that is trade secret or commercial or financial information and is privileged or confidential, or (2) that are medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of privacy." Vaccine Rule 18(b). Otherwise, "the entire decision" will be available to the public. *Id*.

In the absence of a motion for review filed under RCFC Appendix B, the clerk of court shall enter judgment in Ms. Edwards's favor for \$15,188.51. The judgment shall provide that Mr. Edwards's attorney of record, Ronald C. Homer, Esq. (Mr. Homer), may collect \$14,804.51 from Ms. Edwards.<sup>3</sup> Under Vaccine Rule 11(a), the parties may expedite entry of judgment by filing a joint notice renouncing the right to seek review.

The clerk of court shall send Ms. Edwards's copy of this decision to Ms. Edwards by overnight express delivery.
