DECISION¹

GOLKIEWICZ, Special Master.

Petitioners' counsel filed a Motion for Attorneys' Fees and Costs on April 11, 2011, requesting an award of \$8, 367.42 in attorneys' fees and other litigation costs. Respondent's counsel, Traci Patton, orally indicated on April 29, 2011 that respondent does not oppose petitioners' request for attorneys' fees and other litigation costs.

In accordance with Vaccine Rule 18(b), a party has 14 days to identify and move to delete medical or other information, that satisfies the criteria in § 300aa-12(d)(4)(B). Further, consistent with the rule requirement, a motion for redaction must include a proposed redacted decision. If, upon review, the undersigned agrees that the identified material fits within the requirements of that provision, such material will be deleted from public access.

After reviewing the request, the court awards **\$8, 367.42** in attorneys' fees and other litigation costs of which **\$8,041.00** shall be made payable jointly to petitioners and petitioners' counsel, Ajalat & Ajalat, LLP. The remaining **\$326.42** shall be made payable solely to petitioners. The court thanks the parties for their cooperative efforts in resolving this matter. The Clerk shall enter judgment accordingly.²
