DECISION AWARDING ATTORNEYS' FEES AND COSTS ¹

On July 21, 2013, petitioner filed a motion for an award of final attorneys' fees and reimbursement of costs in this case. Respondent failed to file any response to petitioner's motion. Petitioner is entitled to reasonable attorneys' fees and costs pursuant to §§ 15(b) and (e)(1). Petitioner seeks attorneys' fees and costs in the amount of \$16,994.09 for her attorney, Clifford J. Shoemaker, and an additional \$824.78 for costs borne directly by petitioner, Tracy Perl.

The request for attorneys' fees and costs is granted. Petitioner is awarded reasonable attorneys' fees and costs pursuant to §§ 15(b) and (e)(1), as I find that the

petition was brought in good faith and upon a reasonable basis, and the amounts requested are reasonable and appropriate.

Pursuant to §15(e), I award a sum of \$16, 994.09 to be paid in the form of a check payable jointly to the petitioner and petitioner’s counsel, Clifford J. Shoemaker, and a sum of \$824.78 to be paid directly to petitioner, Tracy Perl. ²

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the Clerk of the court shall enter judgment in accordance herewith.³

² This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, “advanced costs” as well as fees for legal services rendered. Furthermore, § 15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See generally Beck v. Sec’y of Dep’t Health and Human Services, 924 F.2d 1029 (Fed. Cir.1991).
