ATTORNEYS' FEES AND COSTS DECISION¹

LORD, Chief Special Master.

Petitioner in the above-captioned case filed a motion for attorneys' fees and costs (the "Application") on November 30, 2010. Petitioner filed an amended Application on December 8, 2010. Petitioner requests a total amount of \$42,334.46 in attorneys' fees and costs. This amount represents \$36,153.00 in attorneys' fees and \$6,181.46 in costs. In accordance with General Order #9, Petitioner represents that he incurred no personal litigation costs. Respondent has no objection to this request.

The Vaccine Act permits an award of reasonable attorneys' fees and costs. 42 U.S.C. § 300aa-15(e). After reviewing the request, the court finds the requested award of \$36,153.00 in attorneys' fees and \$6,181.46 in costs to be reasonable. Based on the request's reasonableness, the undersigned **GRANTS** the parties' request as outlined in the Application.

Accordingly, pursuant to Vaccine Rule 13, Petitioner is awarded a total of **\$42,334.46** in attorneys' fees and costs.

¹ As provided by Vaccine Rule 18(b), each party has 14 days within which to request the redaction "of any information furnished by that party (1) that is trade secret or commercial or financial in substance and is privileged or confidential; or (2) that includes medical files or similar files, the disclosure of which would constitute a clearly unwarranted invasion of privacy." Rules of the United States Court of Federal Claims (RCFC), Appendix B, Vaccine Rule 18(b). In the absence of a timely objection, the entire document will be made publicly available.

The judgment shall reflect that Petitioner is awarded attorneys' fees and costs in a **check made payable jointly to Petitioner and Petitioner's counsel, Broker & Associates, P.C., in the amount of \$42,334.46.**

The court thanks the parties for their cooperative efforts in resolving this matter. In the absence of a motion for review filed pursuant to RCFC, Appendix B, the Clerk is directed to enter judgment according to this decision.²

IT IS SO ORDERED.
