DECISION AWARDING ATTORNEYS' FEES AND COSTS¹

On April 6, 2012, the parties communicated to the undersigned's law clerk that they resolved the attorneys' fees and costs issues in this case.

In accordance with the General Order #9 requirements, petitioner states that she did not incur any costs to pursue her petition.

L. No. 107-347, 116 Stat. 2899, 2913 (Dec. 17, 2002). Vaccine Rule 18(b) states that all decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would constitute a clearly unwarranted invasion of privacy. When such a decision is filed, petitioner has 14 days to identify and move to redact such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall redact such material from public access.

Petitioner filed a Motion for Attorneys' Fees and Expenses on March 23, 2012, and a Notice of Accidental Omission of Other Expenses on March 26, 2012, initially requesting \$16,625.00 in attorneys' fees and \$15,613.84 in attorneys' costs. After informal discussions with respondent, petitioner now requests \$15,995.00 in attorneys' fees and \$15,613.84 in attorneys' costs to which respondent does not object.

The undersigned finds the amounts to be reasonable. Accordingly, the court awards **\$31,608.84**, representing reimbursement for attorneys' fees and costs. The award shall be in the form of one check made jointly payable to petitioner and Knutson & Mack, LLC, in the amount of **\$31,608.84**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.²
