## **UNPUBLISHED DECISION**<sup>1</sup>

Petitioner Janet Leger filed an application for attorneys' fees and costs on September 24, 2010. The Court awards the amount to which respondent has not objected.

Ms. Leger seeks a total of **\$16,738.70** in attorneys' fees and **\$3,623.59** in litigation costs for the firm of Conway, Homer & Chin-Caplan, PC. Ms. Leger also seeks attorneys' fees in the amount of **\$10,465.00** for her former counsel, Andrew Dodd. Additionally, Ms. Leger filed a statement of costs in compliance with General Order No. 9, stating that she incurred **\$732.18** in litigation costs. Respondent stated that she had no objection to the application for attorneys' fees and costs.

All decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would clearly be an unwarranted invasion of privacy. When such a decision or designated substantive order is filed, the person submitting the information has 14 days to identify and to move to delete such information before the document's disclosure. If the special master agrees that the identified material fits within the categories listed above, the special master shall redact such material from public access. 42 U.S.C. § 300aa-12(d)(4)(B); Vaccine Rule 18(b).

After reviewing the request, the court awards **\$31,559.47** in attorneys' fees and other litigation costs. The court thanks the parties for their cooperative efforts in resolving this matter.

The Clerk shall enter judgment accordingly.<sup>2</sup>
