DECISION ON ATTORNEY FEES AND COSTS¹

Vowell, Special Master:

In this case under the National Vaccine Injury Compensation Program,² I issued a decision on August 18, 2011, denying compensation and dismissing this case. On August 5, 2011, petitioners filed a motion for attorney fees and costs in this matter. In that motion, petitioners' counsel represents that he will reimburse petitioners for any personal litigation costs they incurred compensable under the Vaccine Act. The motion further includes a representation that respondent does not oppose the motion.

I find that this petition was brought in good faith and that there existed a reasonable basis for the claim. Therefore, an award for fees and costs is appropriate, pursuant to 42 U.S.C. §§ 300aa-15(b) and 15(e)(1). Further, the proposed amount

seems reasonable and appropriate. **Accordingly, I hereby award the total \$5,744.25³ as a lump sum in the form of a check payable jointly to petitioners and their attorney, Alan M. Pickert.** Petitioners' attorney shall be reimbursed from this award.

In the absence of a timely-filed motion for review filed pursuant to Appendix B of the Rules of the U.S. Court of Federal Claims, the clerk of the court shall enter judgment in accordance herewith.⁴

³ This amount is intended to cover all legal expenses incurred in this matter. This award encompasses all charges by the attorney against a client, "advanced costs" as well as fees for legal services rendered. Furthermore, 42 U.S.C. § 300aa-15(e)(3) prevents an attorney from charging or collecting fees (including costs) that would be in addition to the amount awarded herein. See *generally Beck v. Sec'y, HHS*, 924 F.2d 1029 (Fed. Cir. 1991).
