### **DECISION AWARDING ATTORNEYS' FEES AND COSTS<sup>1</sup>**

On September 7, 2010, petitioner filed an application for attorneys' fees and costs. Petitioner requested a total of **\$63,386.12** in attorneys' fees and costs, consisting of **\$40,185.61** in attorneys' fees and **\$23,200.51** in attorneys' costs. In compliance with General Order #9, petitioner states that she incurred expenses totaling **\$1,237.50**.

On October 13, 2010, both parties informed the undersigned that petitioner reduced the amount requested in attorneys' fees and costs. The petitioner now requests a total of **\$60,000.00**

Vaccine Rule 18(b) states that all decisions of the special masters will be made available to the public unless they contain trade secrets or commercial or financial information that is privileged and confidential, or medical or similar information whose disclosure would constitute a clearly unwarranted invasion of privacy. When such a decision is filed, petitioner has 14 days to identify and move to delete such information prior to the document's disclosure. If the special master, upon review, agrees that the identified material fits within the banned categories listed above, the special master shall delete such material from public access.

in attorneys' fees and costs, consisting of **\$39,123.74** in attorneys' fees and **\$20,876.26** in attorneys' costs. Respondent does not object to the revised amount. The court finds the revised amount requested by petitioner to be reasonable.

The court awards a total of **\$61,237.50** in this case, representing reimbursement for attorneys' fees and costs as well as petitioner's costs. The award shall be in the form of one check made jointly payable to petitioner and Clifford J. Shoemaker in the amount of **\$60,000.00**. A check shall also be made solely payable to petitioner in the amount of **\$1,237.50**.

In the absence of a motion for review filed pursuant to RCFC Appendix B, the clerk of the court is directed to enter judgment herewith.<sup>2</sup>

**IT IS SO ORDERED.**
